- In case of **PWD and additional seats at IPVS, LUVAS, Hisar** all the eligible candidates **irrespective of their VLDDDET-2025 marks** must report at 9 am in the counselling scheduled on 23.10.2025.
- In case of non-availability of eligible candidate(s), additional seats at IPVS, LUVAS (In-service, J&K, Kashmiri Migrant, Non-Migrant Kashmiri Pandits/Kashmiri Hindus & GNCT Delhi) **will be converted in the State Quota seat(s) at 10 am** as per roster/reservation policy. **The candidates reporting late will lose their right of admission at IPVS, LUVAS.**
- In the event of quota reserved for persons with disability, if remains vacant due to non-availability of handicapped candidates, it may be offered preferably to the Ex-servicemen and their wards and the dependents of Freedom Fighters as per roster/reservation policy. **The candidates reporting late will lose their right of admission at IPVS, LUVAS.**

IMPORTANT INSTUCTIONS

- The candidates have to report for counselling/documents checking and other admission formalities on **23, 24 & 25/10/2025 at 09:00 am in Veterinary Auditorium COVS, LUVAS, Hisar** and shall have to pay fees and other charges there and then. The candidates reporting late may lose their right of admission.
- The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.13 of Chapter-III of the Prospectus-2025, at the time of document checking, failing which they shall be refused admission.
- If any candidate remains absent because of any reason, he/she will be allowed to participate in the next day counselling provided seats are vacant.
- If any candidate got admission in any of the college either in state or management quota seats and if he/she wants to change the college or quota, he/she will not be considered for admission unless he/she vacates the seat by cancelling his/her admission.
- The candidates will deposit the fees in the form of Demand Draft in favour of "Director, IPVS, LUVAS, Hisar" Payable at any scheduled bank at Hisar. Fees is to be submitted in the O/o Dean COVS on the same day after medical fitness test.

1. "The Following fee/funds will not be charged from the students of Scheduled Castes category/Deprived Scheduled Castes category (only those who are eligible for Post Matric Scholarship) at the time of admission in VLDD course of IPVS, LUVAS:

- i. University Admission Fee
- ii. College Development Fund
- iii. College Admission Fee
- iv. Examination Fee
- v. Laboratory Fee
- vi. Tuition Fee
- vii. Amalgamated Fund

However, the eligible SC/DSC category students will pay the security and remaining charges at the time of admission. The students fulfilling the conditions prescribed by the State Government for Post Matric Scholarship (PMS) are required to submit following documents at the time of admission in VLDD course.

- i. Haryana Domicile Certificate
- ii. Latest Income Certificate (issued on or after 01.04.2025) upto 2.5 Lakhs per annum
- iii. Aadhar Card
- iv. SC/DSC Certificate
- v. Undertaking (Annexure-XXII of prospectus) regarding deposition of fee/funds as mentioned above within 15 days of getting post matric scholarship in their account."

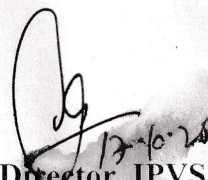
Fees and dues at the time of admission for SC/DSC students who are eligible for Post Matric Scholarship is: **Boys and Girls- Rs. 3870/-**
