Read following instructions carefully:

- (i) The candidates have to report for document checking and other admission formalities on 17.09.2025 at 9:30 am in the O/o Director, IPVS, LUVAS, Hisar (Old College of Animal Sciences Block, Near- Shivalik Hostel) and shall have to pay fees and other charges there and then, otherwise the seat will be declared vacant. The candidates reporting late may lose their right of admission.
- (ii) All the candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.13 of chapter-III of the Prospectus, at the time of document checking, failing which he/she shall be refused for admission.
- (iii) **The candidates claiming reservation under BCA/BCB categories are required to submit latest Income certificate issued on or after 01-04-2025 along with category certificate at the time of document checking, otherwise their candidature for admission by the competent authority at the time of document checking, otherwise their candidature for admission will not be considered. Similarly, EWS category candidate must submit latest Income and Asset Certificate issued on or after 01-04-2025.**
- (iv) The candidates will deposit the fees in the form of Demand Draft in favour of "Director, IPVS, LUVAS, Hisar" payable at any scheduled bank at Hisar.

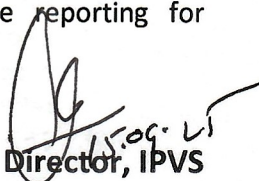
1. In case, candidates are not available in one particular block of BC category, the seats shall be filled up from the candidates of other block as per the prospectus.
2. Where a seat set aside for candidate from deprived Scheduled Castes for admission is not filled up due to non-availability of candidates of deprived Scheduled Castes possessing the requisite qualifications, the same shall be made available to candidate of Scheduled Castes.
3. If reserved category seats still remain vacant due to any reason, the same will be filled up by the combined merit of the candidates on the same day.
4. "The Following fee/funds will not be charged from the students of Scheduled Castes category/Deprived Scheduled Castes category (only those who are eligible for Post Matric Scholarship) at the time of admission in DVLT course of IPVS, LUVAS:
 - i. University Admission Fee
 - ii. College Development Fund
 - iii. College Admission Fee
 - iv. Examination Fee
 - v. Laboratory Fee
 - vi. Tuition Fee
 - vii. Amalgamated Fund

However, the eligible SC/DSC category students will pay the security and remaining charges at the time of admission. The students fulfilling the conditions prescribed by the State Government for Post Matric Scholarship (PMS) are required to submit the following documents at the time of admission in DVLT course.

- i. Haryana Domicile Certificate
- ii. Latest Income Certificate (issued on or after 01.04.2025) upto 2.5 Lakhs per annum
- iii. Aadhar Card
- iv. SC/DSC Certificate
- v. Undertaking (Annexure-XXII of prospectus) regarding deposition of fee/funds as mentioned above within 15 days of getting post matric scholarship in their account."

Fees and dues at the time of admission for SC/DSC students who are eligible for Post Matric Scholarship is: **Boys and Girls- Rs. 3870/-**

5. Any other charges, if applicable and approved by the competent authority will be chargeable at the time of admission.
6. The candidates are advised to visit the University website before reporting for document checking/fees submission/registration.
