Read Following Instructions/Rules Carefully:

- The seats in 2nd online counselling are allotted only for IPVS, LUVAS, Hisar.
- The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.13 of Chapter-III of the Prospectus, at the time of document checking, failing which they shall be refused admission
- In case additional seats at IPVS LUVAS (In-service, J&K residents, Kashmiri Migrants/Non-Migrant Kashmiri Pandits/Kashmiri Hindu Families, GNCT Delhi candidates, SSB, Village Riwasa resident in District Mahendergarh) still remain(s) vacant, after online counselling(s) due to non-availability of eligible candidate(s), the same will be converted in the State Quota seat(s) as per roster/reservation policy.
- For 2nd online counselling, the candidates may deposit the fee in the form of Demand Draft in favour of Director, IPVS, LUVAS, Hisar payable at any scheduled bank at Hisar.

Note:

1. "The Following fee/funds will not be charged from the students of Scheduled Castes category/Deprived Scheduled Castes category (only those who are eligible for Post Matric Scholarship) at the time of admission in VLDD course of IPVS, LUVAS:

- i. University Admission Fee
- ii. College Development Fund
- iii. College Admission Fee
- iv. Examination Fee
- v. Laboratory Fee
- vi. Tuition Fee
- vii. Amalgamated Fund

However, the eligible SC/DSC category students will pay the security and remaining charges at the time of admission. The students fulfilling the conditions prescribed by the State Government for Post Matric Scholarship (PMS) are required to submit the following documents at the time of admission in VLDD course.

- i. Haryana Domicile Certificate
- ii. Latest Income Certificate (issued on or after 01.04.2025) upto 2.5 Lakhs per annum
- iii. Aadhar Card
- iv. SC/DSC Certificate
- v. Undertaking (Annexure-XXII of prospectus) regarding deposition of fee/funds as mentioned above within 15 days of getting post matric scholarship in their account."

Fees and dues at the time of admission for SC/DSC students who are eligible for Post Matric Scholarship is: **Boys and Girls- Rs. 3870/-**

2. Any other charges, if applicable and approved by the competent authority will be chargeable at the time of admission.
