**Note-1:** All the candidates who have applied for DVL Course may participate in this counselling.

**Note-2:** All the Haryana resident candidates who have not applied for admission by filling online application form of Diploma in Veterinary Laboratory Technology (DVL) at IPVS, LUVAS, Hisar but participated in NEET-(UG)-2025 examination and obtained a valid NEET score of 1 and above may participate in this counselling. Such candidates have to register themselves on the spot on 26.09.2025 by paying a registration fee of Rs.5000/-.

**Note-3:** All the Haryana resident candidates who have not applied for admission by filling online application form of DVL at IPVS, LUVAS, Hisar and did not appear in the NEET-2025 but otherwise eligible for admission by registering themselves on the same day by paying the registration fee of Rs. 5000/-.

**Note-4:** i) The candidates who have applied earlier for admission to DVL programme will be considered first for admission.

ii) The candidates who have not applied earlier for admission by filling online application form but participated in NEET-(UG)-2025 examination and obtained a valid NEET score of 1 and above will be considered subsequently.

iii) The candidates who have not applied earlier for admission by filling online application form of DVL and did not appear in the NEET-2025 but otherwise eligible for admission will be considered in the last.

### **IMPORTANT INSTUCTIONS:**

- The candidates have to report for counselling /documents checking and other admission formalities on **26/09/2025 at 09:30 am** in O/o Director, IPVS, LUVAS (Old College of Animal Sciences Block, Near-Shivalik Hostel) and shall have to pay fees and other charges **there and then**. **The candidates reporting late may lose their right of admission.**
- All the candidates are required to bring all the original documents, two recent passport size photos and two sets of self-attested photocopies of documents etc. as per rule 3.12 chapter III of the Prospectus at the time of document checking, failing which he/she shall be refused admission.
- The candidates will deposit the fees in the form of Demand Draft in favour of "**Director, IPVS, LUVAS, Hisar** Payable at any scheduled bank at **Hisar**. Fees is to be submitted in the O/o Director, IPVS on the same day i.e.26.09.2025 after medical fitness test.

**Note:-**

1. "The Following fee/funds will not be charged from the students of Scheduled Castes category/Deprived Scheduled Castes category (only those who are eligible for Post Matric Scholarship) at the time of admission in DVLT course of IPVS, LUVAS:

- i. University Admission Fee
- ii. College Development Fund
- iii. College Admission Fee
- iv. Examination Fee
- v. Laboratory Fee
- vi. Tuition Fee
- vii. Amalgamated Fund

However, the eligible SC/DSC category students will pay the security and remaining charges at the time of admission. The students fulfilling the conditions prescribed by the State Government for Post Matric Scholarship (PMS) are required to submit the following documents at the time of admission in DVLT course.

- i. Haryana Domicile Certificate
- ii. Latest Income Certificate (issued on or after 01.04.2025) upto 2.5 Lakhs per annum
- iii. Aadhar Card
- iv. SC/DSC Certificate
- v. Undertaking (Annexure-XXII of prospectus) regarding deposition of fee/funds as mentioned above within 15 days of getting post matric scholarship in their account."

Fees and dues at the time of admission for SC/DSC students who are eligible for Post Matric Scholarship is: **Boys and Girls- Rs. 3870/-**

2. Any other charges, if applicable and approved by the competent authority will be chargeable at the time of admission.
